**Where:** Torreya State Park picnic area. Go 6.5 miles north of Bristol, FL on Hwy 12 then turn left on Hwy 271 and go 7.5 miles. Stay to the left. Hwy 271 goes into Torreya State Park.

**Registration:** There will be NO RACE DAY REGISTRATION!! **Maximum number of runners capped at 100!**

**Time:** 7:00 a.m. Eastern time

**T-shirts:** To all participants. Be sure to register early to assure your correct size. XXL add \$2, XXXL add \$4.00.

**Entry fees:** \$50 This will include a finish medal to all that finish the Challenge, a colorful wicking T-shirt, awards and a post race meal. **No refunds...if you are unable to attend, the fees will be considered a donation to Torreya State Park.**

**Awards:** 25K: Top 3 O/A male and females, Masters and Grandmasters male and female  
50K: Top 3 O/A male and females, Masters and Grandmasters male and female

**Aid stations:** Aid stations will include water, Gatorade, SaltStick, sodas, chocolate, PB&J sandwiches, new potatoes, chips, fruit and other "ultra" fare

**Runners need to carry fluids! Temperatures may get hot! 4 stocked aid stations. Miles 1, 5, 7, 14, and repeated on the second loop for the 50K. There will be a 9 hour cutoff time! All aid stations will be removed at that time.**
