Place and Course

Apalachee Regional Park, 7550 Apalachee Parkway (US 27), Tallahassee, Florida. The 6K course is twice around a loop that includes grass, dirt, crushed oyster shell, and other natural surfaces. ARPXC is the home course for Florida State University Seminole cross country, and has been the site of the FHSAA High School State Cross-Country Finals, ACC Cross Country Championship, NCAA-D1 South Region Cross-Country Championship, the USATF National Cross-Country Championship, and now the RRCA-Florida State Cross-Country Championship.

Entry Fee

Early registration (received by 12/13) is \$13 (Gulf Winds Track Club members subtract \$2). Race day registration is \$20 for everyone.

Awards

Top overall male and female. First place in age groups (nine and under, 10–12, 13–15, 16–19, 20–24, 25–29, 30–34, 35–39, 40–44, 45–49, 50–54, 55–59, 60–64, 65–69, 70 and over). Running gloves to first 200 registered runners.
